Introduction

Cape Fear Habitat for Humanity ReStore ("we," "our," or "CFH ReStore") is committed to protecting your privacy. This updated Privacy Policy explains how we collect, use, and protect your information specifically in relation to **email communications** and **SMS text messaging**.

By participating in ReStore Rewards or using our appointment scheduling services, you agree to the practices described in this policy.

1. Information We Collect

We may collect the following types of information:

Personal Identification Information

- Name
- Email address
- Phone number
- Date of birth (if provided)

Account & Transactional Information

- Loyalty Program ID
- Membership status
- Purchase history

Communication & Preference Information

- Email subscription preferences for marketing and/or scheduling purposes
 - SMS preferences for scheduling and/or customer care purposes
 - Opt-in status for promotional and transactional messaging via email or SMS

2. How We Use Your Information

Your information is used to support and enhance your experience as a CFH ReStore Customer and Donor.

Email Communications

We use your email address to:

- Send ReStore Rewards updates, point balances, and promotions
- Deliver donation receipts or purchase updates (when applicable)
- Communicate policy updates or program changes
- Provide customer service responses

SMS Text Messaging for Appointment Scheduling

If you opt in to SMS appointment messaging, we may use your mobile number to:

- Confirm scheduled donation or pick-up appointments
- Send reminders and updates related to your appointment
- Communicate time-sensitive changes (delays, cancellations, instructions)

3. How We Share Your Information

Your information will *not* be shared with third parties/affiliates for marketing or promotional purposes. We do *not* sell your personal information. We may share information only under the following conditions:

Service Providers

We may share information with third-party vendors that assist with:

- Email distribution and communications

These partners are required to maintain the confidentiality and security of your data.

Legal Compliance

We may disclose your information:

- To comply with legal obligations
- In response to lawful requests by public authorities

Business Transfers

In the event of a merger, acquisition, or restructuring, your information may be transferred along with organizational assets.

4. Your Choices and Rights

You have the right to manage your communication preferences and personal information at any time.

Email Preferences

You can:

- Unsubscribe from promotional emails via the link included in each email
- Request updates or corrections to your information by contacting us

SMS Text Messaging Preferences

You can:

- Opt out of SMS texts by replying **STOP** to any message
- Request re-enrollment by contacting us directly

Data Access, Updates, or Deletion

You may request:

- A copy of the personal data we hold
 - Updates or corrections
 - Deletion of your information (subject to legal or operational requirements)

5. Data Retention

We retain your personal information only as long as necessary.

- **Minimum Retention Period:** 3 years from your last interaction or purchase
